1) Committee Updates - Bylaws Committee, Committee on Committees, and Executive – Steve Hedstrom updated everyone on the Bylaws Committee meeting in Missoula on Thursday. The committee made some clarifications as to what should be approved by the exec vs the board vs the membership. The goal is to have a draft for the Area meetings. When the new bylaws have incorporated all the legal changes they will be fairly close to complete. There will have to be a lot of coordination with the Committee on Committees.
