EXECUTIVE DIRECTOR'S REPORT

Merger

According to the secretary of state's office website MACD and SWCDM are legally merged. We
are still waiting to receive the certificate of merger, which is needed for the next steps. This
year, we are planning to redesign the MACD website as part of the merger process.

In Person Meeting with Director Kaster and Michael Freeman (Natural Resource Advisor)

• Jim Simpson and Dean Rogge will be in Helena February 26th. We have scheduled meetings with Director Kaster and Michael Freeman and are in the process of scheduling meetings with other appointees and legislators, depending on availability.

CARES Act Reimbursement

• MACD received the \$8,000 reimbursement from Prairie CD. Gallatin CD is still awaiting their reimbursement from the state, and they were in contact with Gallatin County last week.

\$10,000 from DNRC for NRCS computer reimbursement

• Districts have been informed of the \$10,000 available to cover covid-related tech costs that were not able to be reimbursed by the state (Ex. NRCS computers that didn't arrive in time to be reimbursed). A formal application was sent out to districts, and funding for individual districts will be capped at \$2,000 each.

Communications

Our RFP with DNRC for Eric's position was confirmed. Eric has hit the ground running in his first
months as our communications specialist. He has been assisting many districts with website
updates, graphic design, and general tech issues. He has also been working on postcards
updates to the EO website, updates to the MACD website, and a redesigned legislative
brochure.
