Bridger Plant Materials Center (BPMC)

New Business: Partner Reports

Natural Resource Conservation Service (NRCS) -Tom Watson and Kyle Tackett

- NRCS is resuming normal operations in terms of covid
- NRCS has a number of vacant District Conservationist positions across the state that they are actively working to get them filled.
- NRCS is also moving forward with awarding MACD a large agreement similar to in the past and hope to get it done soon. Looking at nearly \$3 million over 5 years.

MT Department of Natural Resources and Conservation (DNRC) - Mark Bostrom and Stephanie Criswell

- The National Association of State Conservation Agencies (NASCA) will be having a high-level discussion with the Department of Interior regarding 30x30. Mark is speaking with Martha Williams tomorrow.
- Admin, 223, district development, and pollinator grants were due at the end April. The RCAC is meeting in Lewistown tomorrow and will review these grants.
- On Friday, May 6th there was a deadline for grants for districts to implement on-the-ground conservation.
 10 RFPs were received and will be ranked by CDB Staff. The focus of these grants will be to benefit multiple districts.
- DNRC CDB is under contract with Big Sky PR on marketing for conservation districts, in collaboration with MACD and the Education Committee's CDOWG (CD Outreach Work Group).

Resource Conservation Advisory Council (RCAC) - Stephanie Criswell

• The RCAC is meeting in Lewistown tomorrow (May 10th and 11th) in Lewistown. In addition to reviewing grants, RCAC will also be looking at renewal and redefining the purpose of the council. DNRC is looking to RCAC to be the advisor for on-the-ground conservation.

Missouri River Conservation District Council (MRCDC) - Molly Masters

- Quarterly meeting will be May 17th in Sydney.
- During the May 17th Water Policy Interim Committee (WPIC) Meeting, MRCDC and the Army Corps will
 present to WPIC on the Fort Peck Test Flows.
- CMR Community Working Group is meeting May 19th in Circle to discuss invasive species.
- The Montana Salt Cedar team is up and running again. The next meeting will be June 22nd in Lewistown. They will be discussing education maps, research by MSU, etc.
- The River Rendezvous will be July 21 and 22 in Petroleum County.

Yellowstone River Conservation District Council (YRCDC) - Judi Knapp

• YRCDC secured ARPA funds for several projects.

Milk River Watershed Alliance (MRWA) - Jeff Pattison

MRWA is working with partners to develop a joint position and is moving forward. This position will be

- funded primarily through NRCS and DNRC.
- Jeff Pattison was invited to go to the NACD Meeting in Fargo, ND, this summer.

Montana Salinity Control Association (MSCA)

• They worked on a project north of Circle last week. They are receiving a lot of requests to look at concerns for salinity. MSCA is also working with Treasure County CD to submit an ARPA Irrigation Grant.

Montana Conservation Districts Employee Organization (MCD EO)

• DNRC entered into a contract with Lewis and Clark representing the EO. The contract is focused around employee onboarding, retention, and offboarding. The contract also includes technical assistance and funding support for the EO to become a 501(c)3. They will put on a new employee orientation this fall. The contract is around \$50,000.

National Association of Conservation Districts (NACD) - Steve Hedstrom

- The entire NACD policy book is being reviewed.
- The NACD Northern Plains meetings will be June 6 and 7th in North Dakota for NACD. Dean and Steve will present on how Montana is operating with AIS.

Additional New Business

Executive Director's Report

- a. Legislative Update The Water Policy Interim Committee (WPIC) and the Environmental Quality Council (EQC) will meet this month to discuss Flathead River Erosion and District Funding, respectively. EQC currently has a draft bill for CD funding, and MACD will give a presentation on a proposed budget. Dean Rogge and Jim Simpson will travel to Helena for EQC.
