Hello conservation districts and partners!

We hope you've seen the previous announcement for Big Sky Watershed Corps (BSWC) host site applications. We are excited to announce that MACD and Little Beaver CD, with the support of the DNRC Conservation Districts Bureau, have funding for conservation districts and partners to host BSWC members focused on soils-related programs and projects as part of a 'Soils Team' pilot.

**If you are interested in hosting a BSWC Soils Team member, you need to do 3 things:**

1. **Contact Kay Webb ASAP** to let her know you are interested. Kay has time allocated to help CDs develop host site projects and ideas and facilitate co-hosting or sharing a BSWC Soils Team member. [littlebeavercd@macdnet.org](mailto:littlebeavercd@macdnet.org) (406)778-2965
2. **Submit a BSWC Host-Site Application** to Montana Conservation Corps (MCC) by **September 2nd, 2022**. You can find more information on the overall [BSWC program here](#)
3. **Apply for Soils Team funding** by **September 16th at 5pm** here: [Soils Team Funding Application](#).
4. **(Bonus #4!)** Attend a BSWC intro call or Soils Team Office hours (see info below).

***Please note:** You will not need to commit to hosting a member until after you hear back about this funding. However, it is important that you get your host-site application submitted to MCC by the Sept. 2 deadline.*

BSWC Soils Team members will provide conservation districts with added capacity to work on soil conservation through projects focused in areas such as education, outreach, monitoring, and demonstration sites. This added capacity will increase districts abilities to conserve soil locally by working with landowners and other partners. Approximately \$33,000 is available.

**Up to \$9,000 may be awarded to each qualifying organization for:**

- 1) Offsetting the \$12,250 cost share payment for hosting a BSWC Soils Team member
- 2) Assisting your member with housing costs

**Additional funds may also be available to host sites for:**

- 1) Purchasing technology for use by the Soils Team member during their term
- 2) Providing funding for member travel.

There will be an introduction/orientation webinar for anyone interested in potentially hosting a BSWC member(s) for the first time. This one-hour virtual meeting will cover the basics of the BSWC program and address questions of potential first-time host sites and supervisors. It is NOT required but highly recommended for any first time host site partners/supervisors.
