- 5. HB 269 was discussed. Greg had concerns about the protection of the trust in the future. MACD could address this on the Senate side, assuming it would pass the House.
- 6. SB 203 ref. foreign ownership had lots of supporters.
- 7. MACD supported the nomination of Christy Clark as the Director of the Department of Agriculture.
