A resolution to coordinate reuse of used infrastructure materials

BACKGROUND DESCRIBING ISSUE *

When the State or a city contracts out an infrastructure project such as redoing a highway, city street with sidewalks, city stormwater drainage system, city water system, etc. there are often materials from the previous infrastructure that get hauled to scrap or otherwise disposed of. These materials could include culverts, pipe, fencing materials, guard rail, and others. While these used materials are not in good enough condition for the new infrastructure, they are often in good enough shape to be used by a producer on a farm or ranch. While many producers would like to have these used materials and many contractors would be in favor of someone hauling these materials away so they don't have to pay for disposal of them, there is currently no streamlined communication avenue to connect the contractor to the producer.

Whereas used materials from state and local government infrastructure projects get disposed of by the contractor doing the infrastructure job, often at a cost to the contractor, And whereas producers would often like to have said used materials for use on their operation.

This policy would require administrative time from MACD to have discussion with state and city personnel. This policy would also lead to administrative time needed from CD administrators to communicate between contractors and producers. The outcome of the success of this policy would be an appreciation of MACD and CD's for supplying materials to producers while decreasing the amount of materials that contractors need to dispose of and making the state or cities look good for providing a route for used materials to be reused.

The application of this policy could cause a slight rise in administrative time and costs to the state and CD's.
