### Resolution 23-02

#### Natural Water Bodies and Land Preservation Disclosure

Submitted by: Missoula Conservation District

### 1. BACKGROUND DESCRIBING ISSUE \*

Many violators of the Montana Natural Streambed and Land Preservation Act (310 Law) say they have never heard of the law, yet there is a disclosure on every residential real estate contract. The disclosure, called the Natural Water Bodies and Land Preservation Disclosure (Lines 187-194 of a Residential Offer to Purchase) states: "Buyers of property in the State of Montana should be aware that some properties contain or are adjacent to streams, rivers, wetlands, floodplains and other water bodies. It is the general policy of the State of Montana that natural water bodies and the lands immediately adjacent to them are to be protected and preserved to be available in their natural or existing state, and to prohibit unauthorized projects related thereto. Property owners should consult their local soil conservation board, a land use profession, or other qualified advisor, regarding any applicable local, state or federal regulations, including permitting or other approvals, before working in or around any streams, rivers, wetlands, floodplains or other water bodies, including vegetation removal."

We believe this disclosure could be a little more clear and helpful if it stated: It is the general policy of the State of Montana, under the Montana Natural Streambed and Land Preservation Act of 1975 (310 Law), that...

And

Property owners should consult their local conservation district, a land use professional...

Having the whole disclosure read:

"Natural Water Bodies and Land Preservation Disclosure: Buyers of property in the State of Montana should be aware that some properties contain or are adjacent to streams, rivers, wetlands, floodplains and other water bodies. It is the general policy of the State of Montana, under the Montana Natural Streambed and Land Preservation Act of 1975 (310 Law), that natural water bodies and the lands immediately adjacent to them are to be protected and preserved to be available in their natural or existing state, and to prohibit unauthorized projects related thereto. Property owners should consult their local conservation district, a land use profession, or other qualified advisor, regarding any applicable local, state or federal regulations, including permitting or other approvals, before working in or around any streams, rivers, wetlands, floodplains or other water bodies, including vegetation removal."

We also believe this statement should be added to every commercial and vacant land offer to purchase as well. We would like MACD to work with the Montana Association of REALTORS® (MAR) to amend their contracts and get this language addended.

The Missoula Conservation District has worked with the Missoula Association of REALTORS® to make sure they are aware of the 310 Law. We have applied to be an official instructor and been approved to teach a continuing education class called "Property and Water Bodies: How to Interpret the Natural Water Bodies & Land Preservation Disclosure,"

"Natural Water Bodies and Land Preservation Disclosure: Buyers of property in the State of Montana should be aware that some properties contain or are adjacent to streams, rivers, wetlands, floodplains and other water bodies. It is the general policy of the State of Montana, under the Montana Natural Streambed and Land Preservation Act of 1975 (310 Law), that natural water bodies and the lands immediately adjacent to them are to be protected and preserved to be available in their natural or existing state, and to prohibit unauthorized projects related thereto. Property owners should consult their local conservation district, a land use profession, or other qualified advisor, regarding any applicable local, state or federal regulations, including permitting or other approvals, before working in or around any streams, rivers, wetlands, floodplains or other water bodies, including vegetation removal."
