### **Irrigator Water Rights**

The State of Montana used the authority of Montana’s Conservation Districts to reserve water for future irrigation development. Potential projects were identified and water quantified and reserved for future development.

Most of Montana’s Conservation Districts don’t have the resources or the expertise to administer water rights.

Landowners developing irrigation may be deterred from using Conservation reserved water due to local politics and personalities. And some uncertainty of making a large investment based on future local administration of reserved water.
